1.0 AUTHORIZATION

The Town of Chautauqua retained the services of Barton & Loguidice, D.P.C. (B&L) to prepare this Map, Plan, and Report for Water District No. 5 in accordance with Article 12A of New York State Town Law.

2.0 BACKGROUND

There is currently no public water service available along the heavily populated Route 394 from County Route 33 to the Village of Mayville line. Town residents in the unserved Route 394 area have petitioned the Town Board to investigate the feasibility of extending public water service to the area. In response to the petition and issues noted by the Chautauqua County Department of Health (DOH), the Town of Chautauqua is exploring alternatives for a new water district.

3.0 EXISTING FACILITIES

Currently, properties in the proposed water district area utilize privately owned groundwater wells for water supply. It has been reported that several wells in this area provide poor water quality or lack sufficient capacity to adequately service homes along the densely developed lakeside area. Some residents have resorted to pumping water directly from Chautauqua Lake when their well doesn't have capacity to meet their needs. Using untreated surface water poses health, sanitary, and safety risks to the residents. According to a 2019 letter of support from the Health Department, nearly 50% of private drinking water samples submitted from the Town of Chautauqua and the Town of North Harmony failed to meet NYSDOH drinking water standards between 2005 and 2019. The extension of municipal water service to the proposed Water District No. 5 area is the only way to ensure each resident has access to safe and reliable drinking water.

4.0 PROPOSED DISTRICT BOUNDARY AND EQUIVALENT DWELLING UNITS

A map of the proposed Water District No. 5 boundary is shown on Figure 1. A written description of the proposed district boundary is included in Appendix A. A parcel list of the proposed water district, including an EDU assessment schedule, is included as Appendix B.

An equivalent dwelling unit or EDU is the unit of measure by which a user is charged for water services. In general, all single-family residences (year round and seasonal) were measured as one (1) EDU, multifamily residences and residential properties with apartments were measured as one (1) per dwelling unit, vacant buildable properties were measured as 0.5 EDUs, and commercial properties were measured based on size and usage. Parcels without a water service connection will be charged for water debt service and not for annual operation and maintenance costs. Parcels with a water service connection will be charged for both water debt service and annual operation and maintenance costs. Based on the EDU schedule in Appendix B and the Water District 5 boundary, the water district would contain an estimated 259 equivalent dwelling units. Of the estimated 259 EDUs, vacant parcels would make up 17 EDUs, while developed parcels would account for 242 EDUs. The number of EDUs in the water district is subject to continuously change.

5.0 PROPOSED FACILITIES




Figure 2 Water District No. 5 Proposed Facilities Map Chautauqua Utility District Connection





Figure 3 Water District No. 5 Proposed Facilities Map Village of Mayville Connection

A detailed comparison of two (2) potential water source alternatives was performed in the May 2023 Water District No. 4 Extension Evaluation Preliminary Engineering Report (PER). At the time the PER was written Water District No. 5 was evaluated as an extension of Water District 4, however it has since been decided to form a new district to give the Town the opportunity to choose between two (2) municipal water sources. The comparison found that water purchased from either the Chautauqua Utility District (CUD) or Village of Mayville water systems would both be feasible, require similar infrastructure, and have similar capital costs to construct. It is recommended that after final district formation, the Town should negotiate with each potential water provider (CUD and Mayville) to obtain the best long-term water rate. The Town will then select a water supplier based on the best negotiated water rates. At this time, the Town has not selected a water supplier and this Map, Plan, and Report has been written to allow for connection to either CUD or Mayville. In order to extend water service to the proposed district, the below list of improvements would generally be required. These improvements largely include the construction of water main in the extension area, which is shown in Figures 2 and 3.

Chautauqua Utility District Connection Improvements

- Installation of approximately 25,560 LF of 8-inch water main
- Installation of approximately 2,440 LF of 4-inch water main
- Installation of approximately 60 Fire Hydrants and 75 Mainline Valves
- Installation of a bi-directional Master Meter at the connection to the Chautauqua Utility District water system
- Purchase of approximately 300 water meters

Village of Mayville Connection Improvements

- Installation of approximately 14,450 LF of 10-inch water main
- Installation of approximately 9,550 LF of 8-inch water main
- Installation of approximately 60 Fire Hydrants and 75 Mainline Valves
- Installation of a bi-directional Master Meter at the connection to the Village of Mayville water system
- Purchase of approximately 300 water meters

6.0 PROJECT COST AND FINANCING

The estimated project cost of the proposed facilities outlined in Section 5.0 is \$9,312,000. Refer to Appendix C for an itemized probable project cost estimate. The cost of water purchase from the Chautauqua Utility District or Village of Mayville will be negotiated after district formation. However, the maximum amount to be expended for the Town of Chautauqua for Water District No. 5 is \$9,312,000.

6.1. Plausible Funding Scenarios

The Town has been awarded \$5,000,000 in Bipartisan Infrastructure Law General Supplemental (BIL-GS) grant funding through the Drinking Water State Revolving Fund (DWSRF) for the new water district. The BIL-GS award letter is included in this report as Appendix D. Based on the scope of this project and the current funding opportunities, potential annual user cost impacts of the proposed new water district are estimated based on the below scenarios:

- Scenario No. 1: 30 year 0% Interest Rate Loan and \$5,000,000 Grant Under this scenario, the Town doesn't receive any additional grant funding and the remaining cost of the project is covered by a 0% interest DWSRF/BIL loan.
- Scenario No. 2: 30 year 0% Interest Rate Loan and \$6,500,000 Grant Under this scenario, the Town receives an additional \$1,500,000 through another funding opportunity such as a congressional earmark, USDA Rural Development grant, or a Community Development Block Development grant and the remaining cost of the project is covered by a 0% interest DWSRF/BIL loan.

6.2. Estimated Project Debt Service

The annual project debt service charge for the construction of the water system will largely be dependent on the project's final grant and loan funding package. Based on two (2) plausible funding scenarios, detailed in Appendix E, debt service costs are estimated to be between \$1,144 and \$1,633 per EDU per year. Final rates will be dependent on both annual project debt service and water purchase rates (to be negotiated). The estimated water purchase costs are believed to be conservatively high as they have yet to be negotiated.

6.3. Estimated Annual Operation and Maintenance Charges

The estimated annual operation and maintenance (O&M) charges for the proposed project is \$125 per EDU based on an estimated annual water budget of \$32,500. Inclusive in the water budget is the yearly estimated cost of labor, equipment, utilities, chemicals, materials, and short-lived asset reserve savings required to operate and maintain the system. Actual O&M costs will fluctuate on a year-to-year basis, but generally increase at a similar rate to inflation.

7.0 IMPLEMENTATION

It is recommended that the Town of Chautauqua Town Board proceed in accordance with NYS Town Law for district formation, generally to include the following:

- Town Attorney reviews Map, Plan, and Report
- Public Hearing
- SEQR Coordinated Review
- Town Board acceptance of this Map, Plan, and Report
- District Formation
- Funding Applications
- Finalize Project funding package
- Engineering Design
- Permitting and Regulatory Approvals
- Bidding
- Construction




Figure 1
Water District No. 5 Boundary Map

BOUNDARY DESCRIPTION
