NOTICE REGARDING SWIMMIMG POOLS REGULATED BY ALL NEW YORK STATE MUNICIPALITIES

Due to the increasing number of casualties, New York State Department of State Codes Division, has stated that above ground pools **Capable** of holding over **24**" of water but less than **48**" high, must be fenced in. All inflatable pools **Capable** of holding **24**" of water or higher must be fenced in. An approved pool alarm is required for any new pool.

The fence must be 48" high and be equipped with a self-closing, self latching gate that swings outward, away from the pool with the lock on the pool side of the gate.

All pools also require a building permit and in some municipalities the electric must be performed by a licensed electrician, and then inspected by a third party qualified electrical inspector.

Please contact your Building Department to schedule an appointment to meet with a Building Inspector to issue you a permit.
